

## **West Winch Parish Council**

Minutes of the Ordinary Meeting held on Tuesday 19<sup>th</sup> November 2019 at 7:30pm in the Village Hall, William Burt Centre, Watering Lane, West Winch.

## 1. To Receive Reports from County Councillor and Borough Councillors.

<u>Cllr P Gidney – A</u> meeting took place on the 6<sup>th</sup> November for all the landowners involved in the West Winch and North Runcton Development to discuss Section 106. There is a proposed development at Hunstanton which will include the sea front and two building proposals. The proposals are currently online and comments can be made. There have been a number of defibrillators installed in King's Lynn. The locations are Kenneth Bush solicitors in New Conduit Street, Youngsters world in Norfolk Street, Ward Gethin Archer in The Tuesday Market Place, Above the water fountain at the bus station, Beside the ticket machine in the Saturday Market Place, On the pontoon at the South Key opposite Marriott's warehouse. Several lives have been saved thanks to the defibrillators being there.

Borough Councillor S. Nash arrives 7:35pm

The Mayor design awards which is a bi annual event, anyone can enter and it closes 17<sup>th</sup> April 2020. The Christmas light switch on will take place on the 28<sup>th</sup> November. There will be a lantern parade for the children before which will start at the stories of Lynn at 5:30pm.

<u>CCIIr Ms A Kemp</u> – Is trying to stop 300 homes being built before the relief road is built. She explains that this is unacceptable as in Norwich the infrastructure came first. It is suggested the Parish Council write to County Council to express their views.

<u>Mineral and Waste Plan</u> – West Winch is one of the only places that could be affected by fracking and the policy should say no incineration or fracking in Norfolk. The Borough needs to put in a strong response.

<u>Fire Service Consultation</u> - There is currently a consultation running on the fire service. It will run until 10<sup>th</sup> December and comments can be made online.

<u>The Budget consultation</u> - the County Council wants to put the council tax up by 3.99% half would go to social care.

Buses consultation - There are no plans in the transport strategy to include park and ride or more buses. A10 cycle route county officers refused to meet due to the transport study.

Walnut Avenue North - There have been some issues with Walnut Avenue and Walnut Avenue North with the ambulances having to turn around as the is no way though.

Speed Camera at Setchey - There is no definitive answer on the speed camera at Setchey.

Market Bus - The market day bus the runs on a Tuesday has been withdrawn.

# 6. To Report on Items not on the agenda from the last meeting: Clerks Report (information only)

The Clerk reported on the SAM2 sign Which has now been moved from Oak Avenue to Hall Lane. There is no update on the Setchey Village sign or the West Winch sign as awaiting a quote. The Sound system sounded better when moved to a different location within the hall. The Tree roots at the skate park will hopeful be dealt with within the next 2 weeks. The gate at the Tennis court has now been fixed. Cllr Thrower and Lamb carried out the work on Sunday Morning. The Pound quote has been sent through to Zurich and we are awaiting a response.

Signs at Gravelhill Lane regarding the cars for sale still awaiting a quote. Football Changing rooms the Hot water is now back on. HGV sign at the top of Watering Lane a quote has been received. This will now be resolved in closed session.

  - i) To Report on the memorial garden Cllr Skerritt reported that the posts can be made and provided cheaper by another company.
  - ii) Consider wording on the Peace Garden Plaque Cllr Skerritt and Cllr Mrs M Summers The two Councillors have discussed the wording and have found a compromise so the new agreed wording for the plaque will be VE Day 75, In honour and remembrance of all local people who fought abroad or toiled at home to bring peace to Europe on 8th May 1945. This was proposed by Cllr Lamb and seconded by Cllr Shearn all were in favour This matter is now **RESOLVED** and the plaque will be ordered
  - iii) To Consider the type Celebration's on the day Cllr Skerritt suggests that a working group is formed with members of the Parish Council and members from outside groups. The Mayor has been contacted to ask if he would officially open the memorial garden but there has been no reply. A grant will be applied for through the National Lottery but it can take up to 18 weeks to process. A grant has also been applied for through the County Council and the Borough Council. It is proposed by Cllr Mrs J Jackson that the working group can use a float of £250 for things such as leaflets and advertising. This is seconded by Cllr Mrs M Summers with all in favour. It is **RESOLVED** to allow the working group £250 for expenses.
- c) To Consider and resolve what to use for NCC partnership bid 2019/20 The Trod or a 20mph sign near the school. Both options were considered and it was **RESOLVED** that the NCC Partnership Bid would be used for the trod at Setchey. *Clerk to complete and submit the application form.*
- d) To consider and resolve installing a CCTV system A meeting took place with the CCTV company before the meeting where is was agree to have a trail of the cameras to make sure that they will meet the needs of the Parish Council.

- e) To consider replacing the wet pour in the Play Area After discussing the quotes in closed session it is decided to find out the cost of replacing some of the equipment in the play area. Other play area will be looked at for ideas and the clerk will get some quotes.
- f) To consider changing suppliers for our Streetlight electricity The Quote was discussed in closed session and it was **RESOLVED** to enter a three-year contract with E.ON.
- g) To consider and resolve method of preventing parking along entrance into William Burt Centre. Cllr Dell informed the council of the two options. Option one was to put in steel posts along the edge for the grass and option two was to put wooden posts. Both options were considered and it was **RESOLVED** to install the steel post. Cllr Dell, Cllr Burt and The Handyman will organise the work to be carried out.
- h) To consider and resolve removing the ivy from the fence around the tennis court. Quote to be considered in closed session. the quote was considered in closed session and it was **RESOLVED** to go ahead with the removal of the ivy. *Clerk to contact CGM to inform them to go ahead with the work.*
- i) To Consider and Resolve proposed amendment to Standing Order 3. Meetings Generally. Item f. Change time allowed to 5 minutes. This was considered and it was proposed by Cllr Gibson and seconded by Cllr Mrs J Jackson that these changes are made to the standing orders. This was agreed by all councillor's present. It was **RESOLVED** to change the standing orders. Clerk to update standing orders and put the amended version on the website.
